Mayor Pro-Tem Spear also inquired on the scenario of new businesses coming into the boundaries of the district. Ms. Baird stated the new businesses coming into the district boundaries would be subject to the Community Improvement District parameters. Councilman Spohn asked about the contiguous boundaries and if those properties not within the boundaries would have voting rights. Ms. Baird said those property owners would not have voting rights since they are not part of the district. Councilman Kowalski asked about the parts of the road not included in the boundary map. Brian Rice, Chamber Director explained the areas that were residential that are not included. Molly McGovern, City Manager explained they could not include the neighborhoods and thus, the right of way next to those properties were not included. Visitor, Chad Taylor asked about the property of the Lawn & Garden LLC business and Lawn & Garden LLC parking lot. Molly McGovern explained the property on Business 69 Hwy is included, and the property with the parking lot and business on Corum Road is excluded. The train tracks by Corum Road were excluded because there was a conflict of ownership. Visitor, Julia Goldstein Westerheidi wanted to clarify that the yellow portion of the map on 69 Highway would still be treated the same as the rest of 69 Highway that is included in the Westside CID boundaries, but was excluded only because of the residential area. Molly McGovern said the RAISE grant would cover the improvements in that area.
